

# FIRM Job Description

Title: Community Health Worker/Contact Tracer

**Hours:** Temporary Full-Time (40 hours per week, non-exempt, grant-funded position)

Reports to: COVID19 Program Manager

**Purpose:** To ensure all Fresnans have access to the information about COVID19 that they need to keep themselves and their families safe. To provide Contact Tracing services in a language spoken by refugee communities in Fresno County.

## **Job Responsibilities and Duties**:

- Share timely and accurate information through social and ethnic media to the Hmong, Lao, Khmer, Russian, Ukranian, Arabic, Vietnamese, Ethiopian, and/or Thai communities
- Attend community testing events to provide outreach and education about COVID19 and programs that
  exist to help people with suspected or confirmed cases stay home and stay safe
- Provide remote case management services in-language to help people with suspected or confirmed cases of COVID19 stay home and stay safe
- Input data entry information into data programs
- Conduct contact tracing and case investigation in a language other than English
- Enroll clients in qualifying programs and provide case management follow ups
- Work with FIRM staff and community partners to achieve outcomes of grant program
- Attend and engage in all meetings pertaining to program
- Provide support for coordinated events as needed or directed by supervisor
- All other duties as assigned

#### Qualifications:

- At least 2 years of experience working in community outreach and/or education programs
- Fluent in <u>speaking and interpreting</u> a language spoken by refugee community members in Fresno (Hmong, Lao, Khmer, Russian, Ukranian, Arabic, Vietnamese, Amharic, and/or Thai)
- Connection to the Southeast Asian, Arab or other immigrant/refugee communities in Fresno County
- Excellent communication skills, verbal and written
- Resourceful, excellent problem solver
- Ability to multi-task and to work under pressure
- Ability to work from home and comfort providing in-person outreach
- Ability to log activity and complete reports in a timely manner
- Willingness to learn new skills and share information with the community
- Reliable transportation, insurance coverage and valid driver's license
- Proficiency in the Microsoft Office Suite, webforms and regular use of e-mail

### Preferred:

- Experience working in a non-profit work environment or a social service setting assisting people in need
- Experience working as a Community Health Worker or Promotora
- Experience working in an outcomes driven grant program
